GMDA/NWRA: Stronger Together

Groundwater issues have gained increasing attention from lawmakers. GMDA, organized to enable local districts across the country to communicate and exchange strategies and technical information, found itself without the means to effectively participate in the national legislative process. The National Water Resources Association (NWRA) already had a network in place, but its traditional role for the 17 western states that make up the NWRA was chiefly oriented toward surface water. By letting GMDA become its groundwater caucus, NWRA broadened its spectrum while allowing GMDA benefits to remain unaltered as an organization. GMDA got the added benefits of a Washington office through which legislative communications could be channeled and groundwater matters within the federal government purview could be monitored. Also, inclusion of GMDA as the groundwater caucus provides a greater audience for the discussion of groundwater issues and the necessary collaboration of surface and groundwater interests.

As a member of the NWRA or of my state association that is affiliated with NWRA, do I need to belong to GMDA?

Dual memberships are strongly recommended. NWRA membership does not automatically qualify you to participate in the policy deliberations of the GMDA at the NWRA Groundwater Caucus. A membership in GMDA lets you add your voice (and vote) to that of your state organization. The transfer of information that strictly relates to groundwater still occurs within GMDA and may not get to you as quickly and efficiently through a state association.

If I belong to GMDA, why would I also join NWRA?

For groundwater issues to be best represented by NWRA to Congress and Administration, groundwater issues need to be represented within the various caucuses, constituents and the general membership of NWRA.

CONFERENCES and BOARD MEETINGS

GMDA holds a winter and summer conference every year. The locations vary across the United States in order to learn about the differences and similarities that exist when dealing with water issues. Additionally, NWRA schedules groundwater caucus work sessions at their national meetings. It is both a learning and a teaching experience at the same time. We come together with the common goal of developing policy and programs that will lead to the best management of our country's most valuable resource, WATER.

Membership Options

DISTRICT membership is open only to those districts that have major programs and responsibilities for groundwater development, conservation and management, and which are chartered under the laws of their respective states. Dues are \$350 annually.

ORGANIZATIONAL membership is open to those organizations as associations whose major purposes are in the development, conservation and management of groundwater. Dues are \$250 annually.

AFFILIATE membership is open to those organizations, businesses or partnerships affiliated with the interests and purposes of GMDA. Dues are \$125 annually.

INDIVIDUAL membership is open to those individuals interested in the purposes of GMDA. Dues are \$25 annually.
